

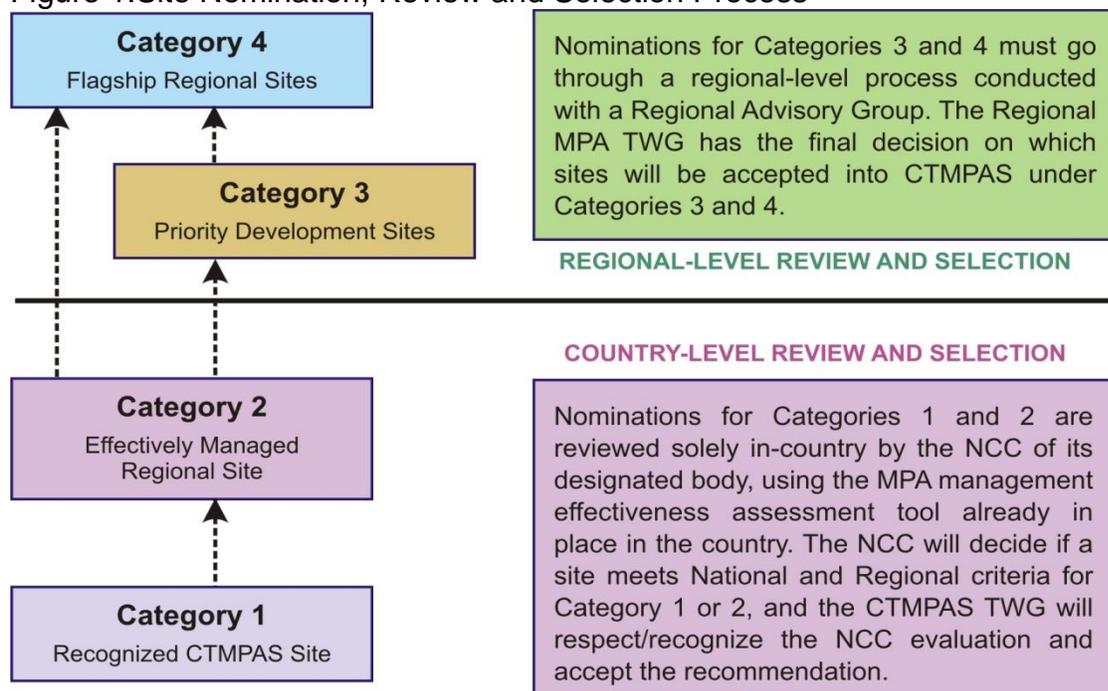
Coral Triangle Marine Protected Area System (CTMPAS) Nomination Form for Categories 3 and 4^a

Background

The Coral Triangle Marine Protected Area System (CTMPAS) aims to foster a comprehensive, ecologically-representative and well-managed region-wide system of prioritized individual marine protected areas (MPAs) and networks of MPAs that are connected, resilient, and sustainably financed thereby contributing towards (i) generating significant, income, livelihoods, and food security benefits, (ii) conserving the region's rich biological diversity, and (iii) climate change adaptation and mitigation. The CTMPAS is expected to synergize with and complement existing initiatives in the region such as the Sulu-Sulawesi Marine Ecoregion and the South Pacific Regional Environment Programs.

The CTMPAS will include four categories of MPAs and MPA networks, namely, Category 4 – Regional Flagship Sites; Category 3 – Priority Development Sites; Category 2 – Effectively Managed CTMPAS Sites; and Category 1 – Recognized CTMPAS Sites as shown in the conceptual framework below. These categories are not strictly hierarchical, but Categories 3 and 4 are intended to contain sites of special or exceptional regional importance and must be reviewed by a Regional Advisory Committee working with the Regional MPA-TWG.

Data and Information Requirements for Sites Nominated for Category 3 or 4

To be accepted under Category 3 or 4, a site must comply with requirements under Category 1 and satisfy the criteria to pass the regional review. Below are the basic data requirements for Category 1 (required for entry in the Coral Triangle Atlas) and the data requirements to help the regional review process objectively assess the nominated MPAs for possible inclusion in CTMPAS Categories 3 or 4. Please provide attachments or weblink for available supporting documents.

Each nomination is rated by assigning points to each criterion listed in the table below. To be accepted as a Category 3 site, an MPA or MPA network must achieve a minimum total score of 50 points (out of 100). To be accepted as a Category 4 site, it must score 80 points or more. This rating system will be used by the Regional Advisory Committee and MPA-TWG for all nominations.

2.3.2.	Replication	Give a summary description showing that habitats and species are replicated within highly protected areas to safeguard against disturbance events.
2.3.3.	Resilience	Give a summary description showing that critical sites for ensuring the resilience of coral reefs and associated habitats are identified and protected.
2.3.4.	Connectivity	Give a summary description showing that the size, spacing and location of MPAs are informed by the home range, larval dispersal distances, and habitats utilized by focal management species.
2.3.5.	Critical areas protected	Give a summary description showing that the nominated site protects spawning aggregations, nesting and nursery areas, critical habitats for key species, etc.
