 - b. Review and agree on the draft operations plan, budget and process for developing the CTI administrative and accounting systems.

- 1. Identify delegates to represent your country and/or institution. There will be a maximum of three delegates for each country at the head table.
- 2. Ensure that delegates are well-briefed in the objectives and agenda of the meeting, as well as documents to be reviewed.
- 3. Promptly send your nominees to give ample time for delegates to process for visa application requirements and for organizers to timely finalize your travel arrangements.
